Postal Service of the members of the FMIF

- 2. On 12 May 2015, Murray Daniel, a Supervisor at BDO, provided me with:-
 - (a) a copy of the "Notice to Members of Application by J Park & G Muller" (Notice); and
 - (b) a list, that he informed me, and I believe, contained the postal addresses of the members of the LM First Mortgage Income Fund (FMIF), whose preferred method for contact was via post (Postal List),

and instructed me that each addressee on the Postal List was to receive a copy of the Notice by post. Mr Daniel instructed me to organise the Notice to be printed and prepared for mailing to the members of the FMIF by Worldwide Printing Solutions, an external provider of these services.

- 3. On 12 May 2015, I emailed to Wayne McKay, the Director of Worldwide Printing Solutions, a copy of the Postal List provided to me by Mr Daniel, and a copy of the Notice. I instructed him to place a copy of the Notice in a pre-paid envelope, and address each envelope to a name and address contained on the Postal List.
- 4. On 12 May I provided Mr Daniel with a revised Postal List that highlighted a number of addresses that could not be sent a Notice as the addresses were either incorrect or incomplete.
- 5. On 12 May 2015, I contacted Mr McKay and informed him that only 3,895 of the Notices were to be posted, as opposed to the 3,991 as originally instructed. Mr McKay informed me that the Notices had already been printed and that the invoice for the Notices would be for printing 3,991 copies of the Notice.
- 6. On 12 May 2015, Worldwide Printing contacted me and informed me that the mail had been prepared and posted at an Australia Post Office.
- On 12 May 2015 I informed Mr Daniel that the Notices had been printed and mailed by Worldwide Printing Solutions.

- 10. On 22 May 2015, I provided Mr Daniel with a copy of the Australia Post lodgement notice that was emailed to me from Worldwide Printing Solutions on 13 May 2015.

Discrepancy between number printed and number posted

- On 22 May 2015, Mr Daniel instructed me to undertake reconciliation due to a discrepancy between the numbers of Notices that were posted versus what was printed. I advised Mr Daniel that the total number of mailing addresses from the Postal List that were not sent the Notice, was 96, in accordance with those addresses from the Postal List that were either incorrect or incomplete.
