1. Pursuant to Rule 388 of the Uniform Civil Procedure Rules 1999 paragraphs 14 and 15 of the orders made on 17 October, 2017 be amended by:

(a) replacing the amount of \$4,569.76 (plus GST) in paragraph 14 with the amount \$119,583.61 (plus GST); and

- (b) replacing the amount of \$11,583.61 (plus GST) in paragraph 15 with the amount \$88,568.62 (plus GST).
- 2. The First Applicants be paid the sum of \$1,116,664.77 (plus GST) from the scheme property of the LM First Mortgage Income Fund ARSN 089 343 288 ("FMIF") for their remuneration as administrators of the Second Applicant, such sum to include:
- (a) the sum of \$979,033.22 (plus GST) for Category 1 claims; and
- (b) the sum of \$137,631.55 (plus GST) for the FMIF 25% share of the Category 2 claims referred to in paragraphs 8 & 9 of the Order dated 17 October 2017.
- 3. The First Applicants' remuneration as liquidators of LMIM, save for corporate remuneration, for the period 1 August, 2013 to 30 September, 2015 be fixed in the amount of \$1,982,460.17 (plus GST).
- 4. The First Applicants be paid the sum of \$673,901.28 (plus GST) from the scheme property of FMIF for their remuneration as liquidators of the Second Applicant, such sum to include:
- (a) the sum of \$511,041.78 (plus GST) for Category 1 claims; and
- (b) the sum of \$162,859.50 (plus GST) for the FMIF 25% share of the Category 2 claims referred to in paragraphs 18 & 19 of the Order dated 17 October 2017.
- 5. The First Applicants be paid the sum of \$14,831.37 (plus GST) from the Scheme Property of the FMIF for separately identified expenses as administrators of the Second Applicant.
- 6. The First Applicants be paid the sum of \$21,807.81 (plus GST) from the Scheme Property of the FMIF for separately identified expenses as liquidators of the Second Applicant.

7. The First Applicants' costs of the Further Amended Originating Application be paid on an indemnity basis from the scheme property of FMIF, LM Australian Income Fund("AIF"), LM Australian Structured Products Fund ("ASPF") and LM Cash Performance Fund ("CPF") in the following proportions:
