- 2. The remuneration of David Whyte, as the person responsible for ensuring the FMIF is wound up in accordance with its Constitution for the period 1 October 2014 to 30 April 2015 be fixed in the amount of \$1,761,911.25 (inclusive of GST).

  - (iii) OVST Pty Ltd (In Liquidation) (Controllers Appointed) ACN 103 216 771;
